- T levels require 45 days of industry placement
- Failure to achieve this:
  - Negatively impacts QAR
  - Negatively impacts provider cashflow
- This element of the T level has represented a challenge for a variety of reasons.
- eVolve Your Future has held a DfE contract to broker placements between colleges and SME's in the Built Environment since June 2022
- DfE now withdrawing all brokerage support, passing the business engagement burden to FE
- DfE support ends 31 March 2024 the need to act is immediate
